Pursuant to Florida Statute 318.14(4) you have thirty (30) calendar days from the date you receive your citation to select one of the following options. Please note: We DO NOT honor postmark dates. Carefully read this form before selecting your option. You may also pay your fine with a credit/debit card or elect to attend a Driver Improvement

Course (if eligible) and pay the fine amount within thirty (30) calendar days by going online at [www.myfloridacounty.com](http://www.myfloridacounty.com). Enclose a copy of your citation with this form. You should maintain a copy of all information for your records.

Initial only one of the following options and complete the form below. Payment received without this form will be returned and may be subject to late fees and driver license suspension. Option may NOT be changed once payment is received.

\_\_\_\_\_ **OPTION 1. Pay Fine.** See Fee Schedule on reverse of this form. Points will be assessed.

\_\_\_\_\_ **OPTION 2. Plead Not Guilty.** By electing this option, you are requesting a Civil Infraction Hearing and you are waiving your right to elect traffic school. A court date will be set and notice will be mailed to the address you provide below.

\_\_\_\_\_ **OPTION 3. Elect Traffic School.** See chart on reverse of this form for fine amount. No points will be assessed. This option is available if you:

1. Have not made an election within the last twelve months or more than five times in a ten year period.
2. Are making this election within thirty (30) calendar days of the date this citation was issued.
3. Have not been charged with a driver license, registration, or insurance violation.
4. Do NOT have a commercial driver license (CDL).

**If you elect the school option you must:**

1. Attend an approved school within the state of Florida. See the Telephone book's Yellow Pages under "Driving Instruction" for available schools, or go online to select and complete the 4 hour basic driver improvement course.
2. Present the certificate of completion to the Highlands County Clerk within ninety (90) days of your payment date. It is your responsibility to provide the original certificate to the Clerk of Court by the due date.

Failure to comply with any of these instructions shall result in a report for suspension of your driver license to The Department of Highway Safety & Motor Vehicles; additional court costs, fines and late fees.
