This permit may be revoked at any time by Lake Placid Code Enforcement if the permitted vendor/peddler violates any condition herein, in town code, in state law, or if any information given herein is untruthful or inaccurate, or if person(s) associated with this permit are found to have unsatisfactory vendor histories which indicate this permit may not be in the best interests of the citizens of Lake Placid.
